**ORDINANCE NO. 2019- 2**

**AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE  
CODE OF ORDINANCES FOR THE TOWN OF ASHLEY, INDIANA, AND  
DECLARING AN EMERGENCY**

WHEREAS, American Legal Publishing Corporation of Cincinnati, Ohio has completed the 2019 supplement to the Code of Ordinances of the Town of Ashley, which supplement contains all ordinances of a general and permanent nature enacted since the prior supplement to the Code of Ordinances of the Town of Ashley; and

WHEREAS, American Legal Publishing Corporation has recommended the revision or addition of certain sections of the Code of Ordinances which are based on or make reference to section of the Indiana Code; and

WHEREAS; it is the intent of the Town of Ashley Town Council to accept updated sections in accordance with the changes of the law of the State of Indiana; and

WHEREAS, it is necessary to provide for the usual daily operation of the municipality and for the immediate preservation of the public peace, health, safety and general welfare of the Town of Ashley that this ordinance take effect at an early date;


NOW, THEREFORE BE ORDINED by the Town Council, Town of Ashley, State of Indiana:


SECTION 1. That the 2019 Supplement to the Code of Ordinances of the Town of Ashley as submitted by American Legal Publishing Corporation of Cincinnati, Ohio, and as attached hereto, be and the same is hereby adopted by reference as if set out in its entirety.


SECTION 2. Such supplement shall be deemed published as of the date of its adoption and approved by the Town of Ashley Council and the Clerk of the Town of Ashley is hereby authorized and ordered to insert such supplement into the copy of the Code of Ordinances kept in the office of the Clerk.
